## Case Study 1

- You travel overseas and purchase jewellery items from your supplier.
- Whilst overseas, you fax us the commercial invoices, details of your return flight to Australia and a return fax number.

- Platinum Freight™ then faxes you the customs entry and receives payment via a credit card authorisation form.

You present the paperwork we have faxed to you and customs allows you to leave the airport with your goods still in your possession. This option is very practical as you are able to keep possession of the jewellery from the moment it was purchased from your supplier.

- Your supplier sends your items via cargo on a nominated airline from overseas
- Your supplier faxes us the paperwork (Commercial Invoice/s together with the airline documents), we liaise with the airline to check the arrival date and time.

- We collect the jewellery from the safe at the airline and deliver to you **or** you can collect the jewellery from our office **or** you can collect the customs clearance paperwork from our office and then collect the jewellery from the airline yourself.
